STATUTORY AUTHORITY

This instrument is executed pursuant to **RCW 87.03.051 — Qualifications of voters and directors—Districts of less than two hundred thousand acres.**

RCW 87.03.051 provides, in pertinent part, that a corporation, general partnership, limited partnership, limited liability company, or other legal entity formed pursuant to Washington law or qualified to do business in Washington and owning land in the district shall be recognized as an elector.

The statute further provides:

“An agent of an entity owning land in the district, duly authorized in writing, may vote on behalf of the entity by filing with the election officers his or her instrument of authority.”
